#### Special Rules for Catch A Goat/ Swine / Lamb

- 1. In order to compete in the contest, the child must be a member in good standing with a Park County 4-H club/must be a member in good standing by the October Livestock Committee Meeting. Youth and parent(s) must be present prior to the contest to review the contest rules with the Park County Livestock Committee (PCLC) coordinator.
- 2. Contestants must have reached the age of eight years, on December 31 of current fair year and have the written consent of their parents. Entrants that will be too old for 4-H participation in the coming year will not be eligible to enter the contest.
- 3. Pen inspections for Catch A Goat/Swine/Lamb animals must be scheduled two weeks prior to animal arrival for initial pen inspection. Progress pen inspections must be scheduled prior to the dates listed below:
  - a. By May 15th for a progress inspection.
  - b. By June 15th for a progress inspection.
  - c. For each progress inspection date not met, an additional 5% penalty will be assessed on the final sale check to the 4-H member.
  - d. After attending the mandatory October orientation meeting and passing the initial pen inspection, you will be contacted by a Livestock Committee Member to make arrangements to pick up your animal. At that time, you will get the name and address of your sponsor for your letters. It is your responsibility to be able to pick up and transport your animal. At any time, your facility can be subject to an unscheduled inspection by the Livestock Committee.

Additional expenses may be required if show


<sup>\*\*</sup>Contestants need to be aware of the expense involved in the market project. In order to complete your project, the typical costs for feed, etc. are estimated to be between \$300 - \$500 for the lamb or goat project and between \$500 and \$700 for the swine project.

f. After passing the initial pen inspection and attending the mandatory October orientation meeting, you will be contacted by a Livestock Committee member to make arrangements to pick up your animal. At that time, you will get the name and address of your sponsor for your letters. It is your responsibility to be able to pick up and transport your animal. At any time, your facility can be subject to an unscheduled inspection by the Livestock Committee.

\*\*Contestants need to be aware of the expense involved in the market beef project. In order to complete your project, the typical costs for feed, etc. are estimated to be between \$1,500 and \$1,800.

Additional expenses may be required if show equipment, grooming products, etc. are needed to participate in the fair. All costs of raising and feeding animals will be the responsibility of the successful

# PARK COUNTY FAIR CODE OF CONDUCT

We are about family, community and positive youth development. To this end we know that youth learn from their experience. Part of their experience is observing and modeling their behavior after adults they know and respect. To contribute in a positive way to youth development Park County Fair volunteers, parents and other adults will:

- Conduct themselves in a mature, courteous and respectful manner, use appropriate language, exhibit honesty, good sportsmanship and act as a positive role model
- Respect the rights and authority of the Fair Board, leaders, parents and Extension Agents.
- Refrain from physical or verbal abuse.
- Apply rules of safety to individuals, groups and property.
- Accept personal responsibility for behavior.

Conduct not in keeping with the Park
County Fair Board standards will not be
tolerated. Violation of items listed above will
result in consequences to the participant/s.
Law enforcement may be called and illegal
behaviors may result in citations or arrest.
Consequences may include removal, at the
individuals' expense and without refund, from
participation in any event; restitution or

before it is lead across the finish line, it is considered loose and anyone may try to catch it. If a lamb gets loose with a halter on it, that halter must be removed by the new contestant who catches it and their own halter shall be placed on the lamb.

- 4. Any 4-H member/contestant who catches an animal and does not complete the project, nor lives up to the signed contract for the program will forfeit the animal to the PCLC, including all money invested in feed and the money derived from the sale of the animal shall be used to purchase an animal the following year to be donated in the original donor's name.
- 5. If the participant moves out of the county before the project is completed, he or she must buy the animal at published market price plus 20% (price based on the weight and market price at the time the contestant received the animal from the donor).
- 6.The Park County Livestock Committee reserves the right to change and/or amend the rules as deemed necessary

#### **Special Rules for Catch A Calf:**

- 1. In order to compete in the contest, the child must be a member in good standing with a Park County 4-H club. Youth and parent(s) must be present prior to the contest to review the contest rules with the Park County Livestock Committee (PCLC) coordinator.
- 2. Contestants must have reached the age of eleven years, by December 31 of current fair year and have the written consent of their parents. Entrants that will be too old for 4-H participation in the coming year will not be eligible to enter the contest.
- 3. Contestants must have completed successfully a prior market animal project (lamb or swine, goat, market beef or breeding heifer).
- 4. Pen inspections for Catch A Calf animals must be scheduled 2 weeks prior to animal arrival for initial pen inspection. Progress pen inspections must be scheduled prior to the dates listed below:
  - a. By December 15th for a progress inspection.
  - b. By February 15th for a progress inspection.
  - c. By April 15th for a progress inspection.
  - d. By June 15th for a progress inspection.
  - e. For each progress inspection date not met, an

species by June 15th.

7. In the event an animal has to be removed from the 4-H'ers possession due to a neglect and/or health issue and it is able to be sold (no vaccine withdrawal period, etc.) the case must be reviewed by the PCLC. The committee will request a written explanation of the issue, corrective actions taken, veterinarian contact information, etc. from the 4-H member/parent.

Based on this information, the Committee will determine how the funds will be distributed based on a review of the health issue, length of time into the project, funds invested in feed, etc. and the 4-H'ers effort to prevent and/or correct the health issue.

- 8. The PCLC reserves the right to request their veterinarian to perform a health check and treatment on any catch animal at any time a health concern is found. Depending upon the diagnosis by the vet, the billing will either be paid by the Livestock Committee or if the vet check determines an illness that is customarily covered by the producer, the vet check and treatment will be the responsibility of the 4-H member for payment.
- 9. All bill of sale documentation involving catch animals will be made out in the name of and retained by the PCLC.
  - 10. All decisions by the PCLC will be final.

#### **2021-2022 GENERAL RULES**

- 1. Any 4-H member who wishes to compete in the contest must submit a Release from Responsibility & Assumption of Risk and Waiver form to the PCLC prior to the contest. The release must be signed by the parent. The Park County Livestock Committee and/or Park County Fair will not be responsible for any accidents connected with this event or the ownership of the animals
- 2. After a 4-Her has successfully caught one animal in the Park County Catch-A-Animal contest; he or she will not be eligible to enter the catch an animal of the same species again in Park County.
- 3. All contestants will carry halters, no lariat ropes allowed. A ten foot lead rope may also be attached to the halter, but may not be used as a lariat. The halter must be placed on the lamb in the usual manner. While a contestant has a hold of a lamb in any manner, those without a lamb may not touch the animal. If the lamb gets away from the contestant

# repayment of damages; and forfeiture of any prize or auction monies.

- 1. The Park County Fair Board (referred to as Fair Board) plus the Extension Agent, have the final and absolute right to interpret these rules and regulations and to settle and determine all matters, questions, incidents, and differences in regard thereto, or otherwise arising out of or connected to the Show, and the right to amend or add to these rules as their judgment may determine. An exhibitor who violates any of the following rules or any other rule stated in this fair book may forfeit all privileges and premiums and may be disqualified from exhibiting at the current and future fairs and be subject to other such penalty(s) as the Fair Board and/or Extension Agent may order.
- 2. Special rules or conditions are published in each department where necessary. If there is a conflict between rules of any department and the general rules and regulations, the special department rules will govern. If two departments conflict, the decision of the Fair Board plus the Extension Agent is final.
- 3. Under no circumstances may an exhibitor, parent, leader, or spectator: badger, insult, or be argumentative with any judge, superintendent, ring steward, or show and fair personnel. Any flagrant display of poor sportsmanship or an affront to the judge or Fair Board personnel by an exhibitor, a parent, or on behalf of an exhibitor may result in exclusion of the individual from the Fair. An exhibitor may be excluded from future competition and forfeit all privileges, premiums and awards, and may be subject to additional penalties as the Fair Board and Extension Agent may order.
- 4. The Park County Fair Board, Park County Commissioners, Colorado State University Extension Agent, the Superintendents, with the assistance of the Park County Sheriff's Office, will use diligence to ensure safety of exhibits after arrival and placement, but in no case will the Park County Fair Board, Park County Commissioners, Colorado State University Extension personnel, or the Superintendents be responsible for any loss, damage, or injury of any property, person, or animal while on the grounds or any time or place, nor be liable for or make any payment for the value thereof.
- 5. The Park County Fair Board, County Commissioners, and CSU Extension do not discriminate in any way in their policies, programs or activities.
- 6. No animal, booth or article will be entitled to a place on the fairgrounds until a proper entry has been made.

- 7. The deadline for ALL ENTRIES in ShoWorks is June 1. Late entries will be accepted until June 14 with a \$5/class fee. There will be an administrative charge of \$25/class for any changes or class drops made to your entries after June 14.
- 8. Open entries are to be made by presenting the exhibit to the Superintendent in charge of the respective division on the date and at the time specified in the Special Rules for that division.
- 9. **All livestock, horse and dog exhibitors** must obtain an exhibitor number at show check-in prior to entering their exhibit with the superintendent in charge of that department.
- 10. The Park County Fair Board and CSU Extension Office personnel assume no responsibility for errors in entry.
- 11. The Park County Fair Board shall reserve the right to limit entries to facilities available and cancel any division or class in which, in its judgment, the entries are insufficient to secure adequate competition. Any limitation of entries under this rule will be done on a non-discriminatory basis.
- 12. The Park County Fair Board and CSU Extension Office shall reserve the right to declare as ineligible and remove any entry that has been entered in violation of these rules.
- 13. Fair Superintendents, after consulting with the CSU Extension Agent, reserve the right to reject any exhibit, make changes in existing rules, or combine classes if such classes will improve the fair.
- 14. Adding classes in addition to those printed in this premium book is at the discretion of the Superintendent with the permission of the CSU Extension Agent.
- 15. The Park County Fair Board reserves the right to exclude from the Fair any person or persons who have violated any of the rules herein. The Fair Board further reserves the right to decline acceptance of entries at any time without statement of reason.
- 16. Articles entered for show in the fair must be the work of the exhibitor.
- 17. No animal or article on exhibit can leave the fairgrounds until released by the Superintendent in charge of that department.
- 18. Judges will not award prizes to an unworthy exhibit. It is the intention of the Fair Board that no premium or distinction of any kind shall be given any

All letters should be hand written and a minimum of 100 words in length. Letters must be postmarked by the end of the month. The sponsor will receive at least one letter per month from the date of the weighin for that species until the fair in July.

NOTE: YOUR LAST SPONSORSHIP LETTER WILL BE COMPLETED AFTER FAIR, SHARING THE RESULTS OF FAIR WITH YOUR SPONSOR(S). THIS LETTER MUST BE POSTMARKED BY THE END OF JULY. YOUR AUCTION CHECK WILL BE ISSUED TO YOU AFTER PCLC RECEIVES THEIR COPY AND RECORD BOOKS ARE TURNED INTO YOUR CLUB LEADER BY THE FIRST MONDAY OF AUGUST.

- 4. The following deductions will be made from the sale price of the animal as required:
  - 5 % Auction Sale Fee
  - 10% Catch An Animal Sale Fee
  - 10% Not making weight
  - 5% for EACH letter not sent on time
  - 5% for EACH inspection not called for on time
- 5. Club attendance, Record book and Marketing Preparation: To be eligible to sell at the Park County Fair Livestock Auction, members must attend a minimum of six of their 4-H Club's community business meetings. Members may make up missed meetings at any Park County chartered 4-H Community Club business meeting. Newly registered members who are not beef project members, must attend a minimum of four meetings.

Club leaders are required to submit their attendance records by the second week of the following month to the Secretary of the Livestock Committee. The attendance records must be signed by the recognized 4-H Club Community Leader.

The record book must be reviewed by their leader prior to the fair for progress prior to the fair to be eligible for showing and/or selling at the Park County Livestock Sale. The record book must be completed and turned into the leader prior to picking up their sale check. Record books are due the First Monday of August.

6. The 4-Her must supply the PCLC with a minimum of two buyers' registration forms for their

complete this project. Contestants must be able to provide transportation for their project animals. Please be sure to take this into consideration when making the decision to participate in the program.

3. The catch animals will compete in two classes – in a Catch-A-Animal Class and the regular 4- H market animal projects in their weight division and will be eligible to be shown for overall Champion. They will sell in their prospective sale order. To maintain the program, 10% of the gross selling price for each catch animal will be retained from the exhibitors check.

# IF YOU ARE SUCCESSFUL – PLEASE TAKE THE FOLLOWING REQUIREMENTS INTO CONSIDERATION:

- 1. Prepare a place for your animal: A secure pen making sure your animal will stay inside and unwanted animals will stay out, with shelter from all elements of weather. You must include a place to store feed and supplies you will need for the project.
- 2. Schedule inspection dates: The 4-H member will contact a CAA committee member before the dates listed in the species special rules section or on the Catch an Animal Calendar to schedule pen inspections. The inspection will be made by the end of each listed month.

An animal shall not be moved to another facility unless the Livestock Committee is notified and an inspection of the new facility is made).

Approval of the pen inspection must be completed at least two weeks prior to the arrival of the animal. If the pen is found to be unacceptable and alternate arrangements cannot be made, the animal will be awarded to an alternate contestant whose name is drawn from a pool of all other contest entrants.

3. Sponsor relations: The 4-H'er will prepare a monthly letter (in triplicate, original to the sponsor, one for their record book and one to be mailed to

telling the sponsor how the animal is doing and any other information the 4-Her would like to include about their project.

animal or article that is not deserving. This rule will be strictly adhered to whether or not there is competition.

- 19. The American system of judging (where exhibits are given blue ribbons for first, red for second and white for third, etc.) will be used for all Jr. exhibits. 4-H Projects will be awarded premium ribbons through 10th place. Superintendents, at their discretion, may utilize the Danish System (where exhibits are given blue ribbons for excellent work, red ribbons for good work, and white ribbons for average work)- i.e. 4-H General and Dog Projects.
- 20. PROTESTS/GRIEVANCES An individual must file a written and signed protest with the Fair Board within 12 hours after the occasion that the protest or alleged violation occurred. The protest must state plainly the cause of the complaint and be accompanied by \$50 cash deposit or certified check, which will be forfeited if the protest is not sustained. Upon receipt of a properly presented protest, the Fair Board President will appoint a committee to review the protest and render a decision, which shall be considered final. The full deposit will be refunded if the protest is sustained. The Park County Fair Board will not be held liable for any decision or penalty invoked as a result of a protest.

# 21. Judges' decisions are final and not eligible for appeal or protest.

- 22. DISPUTES The Park County Fair Board reserves the final and absolute right to interpret the Rules and Regulations, to settle questions of differences, and to assess appropriate penalties for violation of these rules.
- 23. COMMERCIAL PRIVILEGES/ADVERTISING are at the sole discretion of the Fair Board. Under no circumstances will any advertising be allowed to be placed upon buildings, trees, or other places on the grounds, or otherwise distributed without Fair Board permission.
- 24. FAIR FOOD CONCESSIONS— Food or drink vendors (profit, non-profit, youth or adult) may sell any items at the Fair with a signed application and the approval of the Fair Board.
- 25. OPENING AND CLOSING EXHIBIT BUILDINGS :
- a. Exhibit buildings may be open daily. (See Schedule for specific times) The Quonset Building

will be **closed** on Monday, Tuesday of fair week while exhibits are judged.

- b. Exhibit building may be closed at the discretion of the Open Exhibit Superintendent if there is not a supervisor on duty.
- c. Releasing of exhibits: Open class and 4-H exhibits must be picked up from 10 am to 12 pm Sunday or by the Monday after fair by 5 pm. All exhibits left become property of Park County Fair.

26. 4-H Age: All 4-H members must be at least eight years of age, or must not have reached their 19th birthday as of December 31, of the current enrollment year, and must satisfy other eligibility requirements (if specified) for a class, to compete in that class.

# **ANIMAL HEALTH REGULATIONS**

All animals attending the Park County Fair will be required to check in with the Fair Veterinarian, or designated agent, or have a valid health certificate. All animals are to remain loaded until examined and released by the fair veterinarian or agent. Failure to comply will result in **IMMEDIATE** disqualification.

Animals showing signs of contagious or infectious diseases will be released from the fairgrounds at the discretion of the fair veterinarian or a designated agent.

# Please be familiar with the fair schedule and be aware of designated check-in times and places, including Vet Checks.

Any animal originating from a herd under quarantine due to an infectious or contagious disease will be ineligible for admission. Whenever possible, the Fair Veterinarian or Extension agent will perform random vet checks in the barns. The veterinarian will release any animal during the Fair found to be unacceptable. Please be aware that the animal health regulations may be modified at the discretion of the Fair Veterinarian for any unforeseen regional disease outbreaks. Any health questions or concerns should be directed toward the designated Fair Veterinarian or Extension Agent.

#### COLORADO 4-H CODE OF CONDUCT

# 4-H members, leaders, parents, and other adults participating in 4-H programs will:

- 1. Adhere to program rules, curfews, dress codes, policies, and rules of the facility being used.
- 2. Conduct themselves in a courteous, respectful manner, use appropriate language, exhibit good sportsmanship, and act as positive role models.
- 3. Abstain from illegal behaviors, use of alcohol, marijuana, illegal or illicit drugs, and tobacco during 4-H events and activities.
  - 4. Fully participate in scheduled activities.
  - 5. Respect others property and privacy rights.
- 6. Respect the rights and authority of parents, leaders and Extension Agents.
- 7. Abstain from abuse (physical and/or verbal) and harassment.
- 8. Accept personal responsibility for behavior including any financial damage.
- 9. Be responsible for any financial damage caused by inappropriate behavior.
  - 10. Adhere to principles and rules of safety.

Consequences for violating any part of this code of conduct may include, but are not limited to: removal from participation in the event in which the code of conduct has been violated (at the individual's expense); sanctions on participating in future 4-H events; forfeiture of financial support for the event; removal from offices held, etc.

Behavior outside of 4-H activities can affect "member in good standing" or "volunteer in good standing" status.

It is the responsibility of all program participants to reinforce the code of conduct and intervene when necessary to enforce the rules.

#### **Dress Code:**

The following dress has been developed to prevent participants from becoming offended or uncomfortable during any 4-H events or activities. If you choose to dress inappropriately, you will be asked to change. Planning ahead and packing appropriately, will save yourself the inconvenience of changing your attire during the 4-H event or activity and ensure that you contribute to a pleasant 4-H atmosphere. Please be advised that the following dress code will be enforced for all individuals attending 4-H events and activities, including chaperones.

- 1. Clothing: All clothing shall be neat, clean, acceptable in repair and appearance, and shall be worn within the bounds of decency and good taste as appropriate for 4-H events and activities.
- 2. Articles of clothing which display profanity, products, or slogans which promote tobacco, alcohol, drugs, sex or are in any other way distracting, are prohibited.
- 3. Excessively baggy or tight clothing which advertises gang symbols or affiliation is prohibited.
- 4. Items of clothing which expose bare midriffs, bare chests, undergarments, or that are transparent (see-through) are prohibited. Tank tops with straps wider than one inch are permitted. You may enter as many divisions and times as you like. Entries are taken Sunday prior to the fair from 9:00 to 3:00 at the Quonset hut at the fairgrounds. If you can't make it at that time, please email us: admin@parkcofair.com

- 3. No exhibitor shall be entered more than once in the same class or unit or any article entered for more than one premium (livestock is an exception, as 2 are allowed).
- 4. Where records are required as part of the exhibit, they must be complete. Spelling, accuracy, and neatness will always be a priority.
- 5. Non-animal exhibits, must be labeled with name, age, and club of exhibitor. Animal exhibits are labeled on the stall.
- 6. There may be divisions where separate classes are offered: Cloverbuds, members are 5-7 years old; Junior. members are 8-10 years old; Intermediate, 11-13 years old; and Senior: 14-18 years old as of December 31 of the current 4-H year.
- 7. All exhibits must be made by the 4-H exhibitor in the current year.
- 8. All General 4-H projects will be interview judged.
- 9. All exhibits receiving a State Fair Sticker (First Place or Champion of Unit) **must** be brought to the CSU Extension Office by the date and time designated by CSU Extension Agent. *Please do not leave at County Fair!* All Exhibits going to State Fair shall be well packed in a box for handling and transportation by the exhibitor. The CSU Extension Office will provide transportation of exhibits to and from the Colorado State Fair.
- 10. All record books must be signed by the Organizational 4-H Club Leader or this leader may delegate responsibility to an appropriate "project leader" in order for that project to be entered in the fair. This includes general, consumer science, dog, companion animal and horse records.

# **4-H LIVESTOCK SHOW RULES**

#### **Special Rules and Regulations:**

- 1.All general rules and regulations of the Park County Fair and 4-H Show Rules and Regulations pertain to the 4-H Livestock Show.
- 2. A Meat Quality Assurance Program (MQA) is required for all 4-H members enrolled in a Market and/or Breeding Livestock Project.

Once as a first year member who is a Junior or Intermediate member (between the ages of 8 and 13)

Again when a member becomes a Senior (age is 14 years old)

The only exception to being required to take it twice would be for a first time member who was 14 or older, in that case it would only be required once.

Those members not required to attend a MQA Program are encouraged to complete a Quality Assurance Checklist.

To qualify for State Fair as a Swine exhibitor, Pork Quality Assurance must be taken the first three years and then again at age 15.

\*Requirements are subject to change at CSU's recommendation

- 3. An up-to-date livestock/horse record book will be inspected by the Club Leader, or designees, in June. The 4-H exhibitor must make corrections by June 30th in order to participate in the Fair. A final record book is to be submitted to the CSU Extension Agent no later than the 1st Monday in August of the current year.
- 4. Any 4-H member that has received a record book grade of less than 70% shall forfeit any and all awards and prizes, but will be given two weeks to correct the deficiencies and re-submit to the CSU Extension Agent.
- 5. Exhibitors not complying with Rule #4 above will be ineligible to enroll in that same project in the next 4-H year.
- 6. Exhibitors in the 4-H livestock show must have continuously owned, and personally cared for (at least 51% of the time) their livestock on or before the following current year's date or the weigh in date selected by the Park County Livestock Committee for market animals, listed below, <u>and upload proof of ownership to 4honline by the listed dates:</u>

- 9. Exhibitors of all grade gilts and ewes will be required to show an Affidavit of Ownership on any and all animals exhibited. These ownership affidavits must have been issued in the name of the exhibitor and a copy placed on file in the CSU Extension Office by the first Sat. in May of the current year. See affidavit requirements.
- 10. Exhibitors of all market beef, lambs, swine, goats, rabbits and poultry will be required to show an Affidavit of Ownership on any and all animals exhibited. These ownership affidavits must have been issued in the name of the exhibitor prior to date specified in rule number 6 under 4-H Livestock Show.
- 11. An ear tag, leg band, or permanent mark must identify all livestock exhibited in the various market classes. Tagging of animals will be done when they are weighed on dates specified by the Extension Agent and the Park County Livestock Committee.
- 12. Animals deemed unworthy of competition by the Superintendents, Veterinarian or designated agent may be barred from competition and shall be immediately removed from the fairgrounds.
- 13. Exhibitors of livestock must exercise due discretion in regard to the animals they are exhibiting whether in the ring, stall, pen, or other places on the fairgrounds and must assume all responsibility for any damages caused by or to their animals.
- 14. Exhibitors, at all times, must give their exhibits necessary personal attention, and **excellent care** while located on the Park County Fairgrounds.

- 15. The Superintendents shall exclude stock from competition should there be any unnecessary or embarrassing delay on the part of the exhibitors bringing animals into the show or sale rings. There is no appeal or protest for this judgment call.
- 16. Stalls and pens for the Park County Fair will be available in designated areas for the species.

The Superintendents will stall all animals and designate areas for equipment (fitting chutes, etc.) set up and storage.

- 17. Exhibitors must accompany their livestock to the show, care for, and exhibit their animals. Only the exhibitor will be allowed in the show ring during official judging. In case of sickness or emergency, an animal may be shown by a substitute, providing that the substitute is bona-fide 4-H member and permission is granted by the Superintendent and the CSU Extension Agent.
- 18. In market classes, the Superintendents will determine class divisions and the number of animals in each class after the animals are weighed for the "good of the show". Classes and weights will be posted in barns as soon as possible after weigh-in. Heifer clause: if (3) three or more heifers are entered into the competition, there WILL be a MARKET HEIFER division. If less than (3) three heifers are entered, they will be shown in the weight division for market. Weight division will be determined after the weigh-in at the fair and will be posted at the Extension Office and in the Livestock Barn. Every effort will be made to limit the weight differential to plus (+) or minus (-) 50 pounds between classes.
- 19. Market animals can be exhibited by weight, breed, sex or any combination there-of.
- 20. Entry weights will be used for market classes. Minimum market weights are:

Pigs - 225 lbs. Max Sale weight 295 lbs.\* Lambs - 100 lbs. Goats - 50 lbs. Beef Steers - 1,000 lbs. Beef Heifers - 950 lbs.

Sale weight accuracy is +/- 5 pounds.

\* Overweight hogs will sell at 295 pounds.

- 17. A repeat target must be thrown in the following situations, regardless of the competitor's response to the target.
  - A. A broken target was thrown.
- B. The target was thrown from the wrong house.
- C. A target of distinctly different color is thrown.
- D. Either target of a true pair or simultaneous pair is irregular.
  - E. A single target is thrown for a double.
  - F. The competitor fires out of turn.
- G. Another competitor fires at the same target. H. The line officer cannot, for some reason, determine whether the target is lost or a "no target."
- 18. Repeat targets may be thrown under the following conditions, if the competitor does not fire at the target: A. The target was thrown before the competitor called for it.
- B. The target was not thrown within the allowable time limits.
- C. The target flutters, takes an irregular course or has inadequate velocity.
- 19. If a competitor thinks that the scorer has miscalled a lost target (miss) the competitor must immediately challenge the call (before the next shot is fired) to the line official. Once the next shot is fired, the ability to

- 23. Any animal deemed too unruly to handle will be ineligible to exhibit and may be removed from the show ring and/or the Park County Fairgrounds immediately if requested by the Superintendent in charge, the Fair Board, Livestock Committee Member or the CSU Extension Agent.
- 24. Unauthorized persons are not allowed in any show arena. Parents cannot assist children in the show arenas.
- 25. Pens, stalls and tie-outs are to be kept clean during the entire fair and are to be cleaned by the exhibitor prior to being released from the fair.
- 26. Unethical practices will not be condoned. Unethical practices include but are not limited to the following:

Doctoring, doping or injecting show animals for body "fill-ins" or the alteration, changing, defacing, or any modification of the markings of show animals and the anatomical structure of an animal; the removal, alteration, changing or purposely damaging ear tags; any type of injection where oils, glycerin, or like substances are used for body "fill-ins"; external application of such things as liniments and blistering agents that would cause an edematous (swelling) condition; use of ice packs or other refrigerants to alter the quality or finish of an animal. No animal shall be decorated with any unnecessary trappings, etc., during the judging. Trimming and blocking will be allowed. No muzzles of any kind are allowed. The showing of livestock of any ineligible age or showing unethically fitted livestock is prohibited. Any exhibitor found guilty of any of the listed unethical practices, or any other practice deemed unethical by the Park County Fair Board, will forfeit all premium monies, not be allowed to sell in the Junior Livestock Auction


and the owner of the animal may be barred from any future shows.

27. The Park County Fair supports Colorado Revised Statute 18-9-207, an Act Concerning the Unlawful Alteration of Livestock by Tampering or Sabotage. The Fair Board requires compliance with said law by exhibitors.

Violation of this rule and law is a Class One Misdemeanor.

- 28. The Park County Fair endorses and supports the Wholesome Meat Act and requires that all exhibitors are in compliance with said act.
- 29. All livestock will remain the property and in the possession of the exhibitor until they are loaded for shipment and have been accepted by the purchaser as wholesome. The Fair Board assumes no responsibility for loss due to death or injury to any animals during or following the Fair.
- 30. Only animals that have been awarded first place premiums will be permitted to compete for Champion. The remaining first premium winners and the second premium winners in the class from which the Champion was selected may compete for Reserve Champion.
- 31. Any antibiotic, medication, pesticide, or other substance administered to any market animal on the fairgrounds will be administered by or under the **direct supervision of the Fair Veterinarian.**
- 32. The Park County Fair Board reserves the right to screen or test any market animal for drug residues of any nature and take any action deemed appropriate if testing results show any positive residues above naturally occurring levels. Random checks for drug residue and disease may be performed by the Fair veterinarian and/or slaughtering plants. Any 4-H member found to be in violation will forfeit all monies, not be eligible for the 4-H Livestock Auction and may be barred from any future shows.
- 33. Anyone may assist, help or provide guidance to any 4-H member with grooming and/or fitting provided the exhibitor is present. Family members may assist 4-H members with washing and daily care as long as the exhibitor is present. Senior members are encouraged to provide support and help the younger 4-H members.
- 34. Feeding and watering of livestock in the alleyways, on the wash racks, or in the show ring will

- 7. No release triggers allowed.
- 8. A contestant cannot use a shotgun that has a chamber larger than 12 gauge. Ammunition maximum shell length is two and three-quarter (2-3/4) inches except for .410 ammunition. Maximum shot charge is one and one-eighth (1-1/8) ounce. Recommended ammunitions are a standard trap load.
- 9. Targets will be set the morning, before the shoot starts and will not be reset except by the superintendent.
- 10. Standard clay targets of consistent coloration will be used in all 4-H shotgun events.
- 11. The target shall be thrown immediately upon the call. Only the line official may determine a late pull. (If a competitor shoots, the result of the shot is scored.)
- 12. Competitors are allowed two failure to fire alibies per class (50 targets per class). Subsequent failures to fire will be counted as a lost target(s).
- 13. All lost targets will be called immediately by the line official as "Lost or Missed".
- 14. Hit / Broken Target: A target is scored as hit or broken when at least one visible piece of the target is



broken or separated from the target. A target change of direction is not considered a visible piece.

15. Lost / Missed Target: A target is scored as lost or

11. **Arrow Retrieval:** Whenever anyone is beyond the target backers an arrow must be placed in the top of the target backer (straight up) or a safety flag displayed vertically signifying that someone is behind the target backer.

# 12. Rules and Whistle Signals

- A. Competitors will straddle the firing line.
- B. Bows to be drawn in a safe and controlled manner. The arrow must be drawn in line with the designated target.
- C. Bows that fail safety inspection will not be allowed on the range.
- D. Whistle Signals are as follows:
  - One whistle blast: Commence firing
  - Two whistle blasts: Competitors to theline
  - Three whistle blasts: Score & retrieve arrows
  - Four or more whistle blasts: Cease Fire

### **SHOTGUN**

### **General & Range Rules**

# Control of the range will be under the supervision of the Shotgun Superintendent at all times.

- 1. All shotguns must remain unloaded and actions open and empty until the competitor is on the line ready to shoot. Break action shotguns may have the actions closed when they are in the rack. Violation of this rule may subject the competitor to immediate disqualification. Remember: Open or out!
- 2. No reloaded ammunition allowed at any 4-H Competitive Event.
- 3. Competitors cannot insert a live round (shell) in to the firearm until the person before them discharges their firearm.
- 4. No portion of the muzzle shall be allowed to come into contact with any portion of the competitor's body. (i.e.: toe rests are not allowed.) Over-the-shoulder carries are NOT allowed. A two handed carry is highly recommended when practical while carrying uncased rifles, shotguns and muzzleloaders on the firing line and between stations or ranges. Muzzles are ALWAYS to be pointed in a safe direction.
- 5. All Shotgun competitors are required to bring and use eye and ear protection.
- 6. Ready position will be a free gun mount policy.

not be permitted at any time.

- 35. Market animals exhibited in market classes are ineligible to be exhibited in breeding classes and animals exhibited in breeding classes are ineligible to be exhibited in market classes
- 36. Male animals having one or more testicles contained in the body cavity are not eligible to show or sell.
- 37. No stallions over 1 year, bulls, boars, rams that aren't registered in breeding classes or cattle with horns or scurries over 2" long are allowed, the exception is breed standard requirements. Exhibitors of horned animals should exercise extra care and use caution. 4-Hers must make known their horned animals to the CSU Extension Agent with their fair entries.
- 38. All market classes are open to castrated male and female animals.
- 39. Any animals having external fungus or parasites may be disqualified and removed from the fair grounds.
  - 40. All breeds will be combined for judging.

# 4-H LIVESTOCK SHOW DIVISIONS DEPARTMENT 10- 4-H BEEF CATTLE

#### **Special Rules and Regulations:**

The following rules apply to all exhibitors in the Market, Breeding, and Beef Showmanship sections.

- 1. All entries must meet all General Fair Rules and Regulations, 4-H Show Rules and Regulations, and 4-H Livestock Auction Rules and Regulations
- 2. No market steer or heifer born before January 1 of the previous year is eligible to show. Age may be determined by the dentition process. All steers and heifers must have both temporary central incisors (baby teeth) in place. Any evidence of tampering with tooth development will be cause for disqualification. Superintendent's decision will be final. Market Heifers must be open. This will be determined in one of two ways:
- a. Exhibitor submits declaration from their veterinarian stating the heifer is open, dated within 7

days of weigh-in at Fair.

- b. The Fair Veterinarian will palpate or ultrasound the heifer at weigh-in, the cost to be paid by the exhibitor if no declaration is provided.
- 3. Breeding beef entries will be classified according to age as follows: Junior Calf 0-6 months; Senior Calf 7-12 months; Junior Yearling 13-18 months; Senior Yearling 19-24 months; Producing Cow 25 months and over.
- 4. Any aged female that has calved will be shown in the Producing Cow class.
- 5. Exhibitors of all market steers or heifers, feeder calves, breeding animals and dairy females will be required to show some type of ownership papers on all animals exhibited. These ownership papers must have been issued in the name of the exhibitor prior to the weigh-in date of the current year for market steers and heifers, and prior to the first Saturday in May of the current year for feeder calves, breeding beef, and dairy females.
- 6. Carcass Contest— Calves must be shown at the Park County Fair by a bona fide 4-H member to be eligible for competition in the carcass show.

Seniors will shoot five (5) arrows per distance for a total of twenty (20) arrows (200 possible points). Competitors will have a maximum of five (5) minutes to shoot each distance in each round

- **3-D Match -** All archers will shoot 3-D foam targets at unknown distances not to exceed 40 yards. Juniors will shoot one (1) arrows per target at eight (8) targets for a total of 80 possible points. Seniors will shoot two (2) arrows per target at ten (10) targets for a total of 200 possible points. Competitors will have a maximum of two (2) minutes to shoot per target.
- 9. **Cross Fires:** Defined as one competitor's shot to another competitor's target. All cross fires must be reported to the line official immediately, before the allotted relay time expires.

# ARCHERY:

Control of the range will be under the supervision of the Archery Superintendent

#### **General Rules:**

Only the Superintendent(s) or their Assistant (s) are allowed to remove someone from the line or prevent a competitor from going to the line.

- 1. **Draw:** No arrow may be drawn past the back of the bow at any time. A minimum of the arrow tip must extend past the back of the bow at full draw. The tip of the arrow is defined as the entire portion of the arrow point that is inserted, threaded in, glued or affixed into or outside the arrow shaft. All bows must be hand-held at full draw. (Any devices used to aid the shooter must allow for the rule that no arrow can be drawn past the back of the bow).
- 2. **Hand-held Bow:** A hand-held bow is defined as a long bow, recurve bow or compound bow on which the string is not drawn mechanically or held mechanically under tension. String releases or mechanical releases which are hand-drawn and hand- held with no other attachment or connection to the bow other than to the bowstring are acceptable.
- 3. **Poundage:** Maximum draw weight for any bow is sixty (60) pounds. A portable poundage device will be used to check bows. Recurve or Long Bows marked sixty (60) pounds or less will not be checked. Compound Bows will be randomly checked at the Superintendent's Discretion. Competitors with bows found to be over sixty (60) pounds draw weight will be disqualified.
- 4. **Quivers:** All arrows must be in a quiver or arrow case at all times. This includes all Persons attending the State competition youth, coaches, parents, leaders or other adults. Quivers must be properly worn, not carried by Competitors. No ground or pocket quivers allowed.
- 5. **Range Finders / Binoculars:** Range finders and binoculars are prohibited on the archery range.

- 6. Wool sheep may be shorn per usual for the breeding program (typically prior to lambing.) The fleece will be judged separately in the Exhibit hall. The sheep will be judged for its wool merit on the hoof.
- 7. Wool sheep will not have weigh in, nor be washed as part of the fitting process. Wool may be combed to remove debris without removing the curl.

- 1.Market Goat date of birth must be after December 1 of the previous year
- 2.Market goats must be carrying all milk teeth in normal positions.
- 3. Goats must be shorn slick with a maximum of 1/4" of hair for the show and before the animal is weighed in at the Park County Fair. Animals must not show any indication of blocking and must be slick shorn to the skin above the knee and hock joints,

are responsible for their actions, adhering to the 4-H Code of Conduct and upholding the standards of the 4-H Shooting Sports program. All are expected to behave in a manner suitable for the promotion of a 4-H youth development program, high ideals and the promotion of 4-H Shooting Sports. Cooperation, self-control, selfdiscipline and high standards of sportsmanship are expected at all times.

16.Cease Fire: All firearms will be unloaded immediately upon the command "Cease Fire." Actions will remain open and chambers up

Superintendents have final say on questionable equipment and all safety matters. It is the responsibility of the competitor to have all equipment approved prior to the competition.

#### .22-Caliber Rifle Rules

- 1. Firing Line: No portion of the competitor's body may rest upon or touch the ground in advance of the firing line or be more than six (6) inches behind the firing line.
- 2. Clear Bore Indicators (C.B.I.'s): All competitors will use C.B.I.'s that are required to extend a minimum of three (3) inches past the muzzle and the action when not firing, they may be any color.
- 3. Spotting Scopes: Spotting scopes or binoculars will be allowed throughout the match. Spotting Scope bases may be ahead of the firing line, however, the eye piece of the spotting scope must remain behind the firing line.
- 4. Sling: The use of a sling is not allowed in most classes. Any exceptions to this rule will be noted in1. the specific class rules
- 5. Sight Definitions: Open: A combination of an open notch (rear) and blade or post (front) sight. A factory installed hood on the front sight will be allowed. No Lenses. Aperture: Must have a rear peep and front globe that may have interchangeable peep aperture inserts. No Lenses
- 6. Shooting Positions: (Prone, Standing, Kneeling, Sitting): The positions are displayed in Appendix VII on page 51 of the Colorado 4-H Shooting Sports Rule Book and taught by county certified leaders. They will be limited to those described in the "Colorado 4-H Shooting Sports Rifle"

- 9. Disability or Special Needs: Reasonable accommodations for youth with disabilities or special needs will be made for those identified on the entry form. Please also notify the superintendent of any youth with a disability or special need.
- 10. Local Range Rules: The Park County 4-H Shooting Sports Competition takes place at the Como Shooting Range, a public shooting range. We are guests at this range, and therefore must also follow the rules of the range.
- 11. Artificial Rests & Supports: Anytime a firearm is grounded while on the line, it will have the action open and up. Bi-pods or leaning devices may be used to support the firearm only when at rest. Any such device may NOT be used during the shooting sequence.
- 12. Eye protection: Eye protection is required for all shooting activities with the exception of Archery.
- 13. Ear Protection: Ear protection is required for all shooting activities with the exception of Archery and Air Rifle/Air Pistol.
- 14. Footwear: Closed toe shoes are required and must be worn during the course of fire in all shooting disciplines and events.
- 15. Competitor and Coach Responsibility: In all circumstances, competitors, coaches and parents

excluding the tail switch.

- 4. All Market goats will be required to have horns tipped to the diameter of a dime, no sharp points allowed. All Dairy goats must follow breed standard requirements. Removal of horns is not allowed on fairgrounds.

- 2.Age Divisions: All contest areas are divided by Junior (ages 8-13) and Senior (ages 14-18). Age is determined as of December 31 of the previous year. Any eligible 4-H member enrolled in the project may compete. Exceptions of .22 Pistol and Western Heritage, members must be 9 years of age at the start of the current 4-H year.

# 3.Range Management:

- a. Each individual range will be under the direct supervision of the discipline superintendent.
- b. The same firearm/bow must be used throughout the match except in the case of equipment malfunction. The line official **must** be notified immediately of any equipment malfunction.
- 4. 4-H Code of Conduct: The Colorado 4-H Code of Conduct will be enforced at all Colorado 4-H Shooting Sports events and applies to all members, families and volunteers in attendance.
- 5. 4-H Dress Code: The Colorado 4-H Dress Code will be enforced at all Colorado 4-H Shooting Sports events. Dress code will be enforced by the Team Coach. Members who are not in compliance will be asked to correct the issue in a timely manner. If the problem is not corrected the entire team may be disqualified at the Superintendent's discretion.
- 6. Firearm Handling: All firearms must be unloaded and the muzzle pointed upward when off the range. Firearm muzzles must be pointed down range when on the firing line. Break action firearms

type, age-appropriate, properly supervised events or activities sponsored or conducted by

4-H groups. Cloverbuds members do not participate in the ongoing, planned series of activities.

The primary difference between a Cloverbuds activity and a 4-H project is that a Cloverbuds member engages in varied activities which focus on developing a specific skill or concept utilized in completing the activity rather than focusing on a long-term planned course. As a result, Cloverbuds members should not have ongoing projects, of any kind; nor should they participate as competitive exhibitors, because within the 4-H program, exhibits are intended to showcase the culmination of a long-term project.

In general, the handling of animals (large or small) requires discipline and motor skills that have yet to be fully developed in most children in the 5 to 7 age range and when coupled with the unpredictable behavior of animals, does not provide the optimal safe educational environment.

4-H Cloverbuds members that have engaged in a group activity may *exhibit or showcase* in a noncompetitive event, or can feature other items from their group activities. However, Cloverbuds members are not eligible to receive premium funds as a result of exhibition. Cloverbuds members may receive participatory ribbons but may not receive regular competitive purple, blue, red or white 4-H ribbons.

In addition to the educational focus, 4-H Cloverbuds programs also require additional adult supervision, and do not conduct formal business meetings or elect officers.

Cloverbuds clubs handle their finances differently than clubs for older children, with the majority of funding issues handled by the adults.

# Special Rules and Regulations: Market Rabbits

#### Market Rabbits—Meat Pen Class

- 1. Meat pen will consist of three (3) rabbits, weighing not less than 3 1/2 pound and not more than 5 1/2 pounds each not over ten weeks
- 2. All meat pen rabbits must be identified at the June Rabbit Tattoo Date. All rabbits will be identified as they check in to the County Fair. Any rabbits that do not have the proper identification will be excused from the grounds.
- 3. All market rabbits will be weighed and identified once they have passed the veterinary inspection at time of arrival.
- 4. Animals entered in the Market Rabbit Class may NOT be shown in the Breeding Classes.
- 5. Grand Champion and Reserve Grand Champion meat pens must be auctioned off at the Junior Livestock Auction.
- 6. If any one rabbit in the pen is overweight or underweight, the entire pen is disqualified from competition.

# Standard & Guide for Judging Meat Classes (ARBA)

The four factors, in the order of their importance, for judging meat pens, are as follows: (1) Meat type, (2) Condition, (3) Uniformity, and (4) Fur.

- 1. Meat pens shall consist of three rabbits, does not necessarily have to come from the same litter.
- 2. Age limit 10 weeks. No rabbits may be sold under 6 weeks of age.
- 3. Minimum weight 3 1/2 pounds each, maximum weight 5 1/2 pounds each. All rabbits must be weighed in the presence of the judge/ sale committee

# Point Schedule for Judging Meat Pens

Meat Type	40 points
Condition of Flesh	30 points
Uniformity of body & weight	20 points
Fur	10 points
Total	100 points

Meat Type - Points 40: Type is the most important factor in judging meat pens. The best meat type is found in those fryers that are compact and short, with the body well filled, rounded, and solidly fleshed. Smooth, well filled hips and good depth of body are especially important. Protruding hip bones or prominent "razor backs" are serious faults. The width and depth of loin, thickness of hindquarters, and well developed shoulders are important to the meat carrying type of the fryer. The hindquarters are most important, loin second, and forequarters are third in importance.

**Condition -** Points 30: All fryers in a pen must be in prime condition. This reflects the care and management practices of the breeder. The fryers must be firm and solid. They must not show any signs of flabbiness, softness, looseness, or pottiness. The pelt must be tight over the body and the animals must be clean and show no signs of neglect or disease.

**Uniformity -** Points 20: This is a combination of the other three requirements. It denotes the ability of the breeder to pick three fryers for each pen, which have the other three qualities in equal amounts, and will reflect the general quality of the herd from which they came. Uniformity can be present in weight, size, appearance, condition, meat type, and fur, and should be as similar in all respects as possible.

**Fur -** Points 10: Fur should conform to the breed description in the standard and be uniform on all three animals in the pen.

# Rabbit Hopping Special Rules and Regulations

1. All rabbits will be treated safely and responsibly at all times. The rabbit must hop through the course of its own free will. It may not be steered

by hand. Use of the foot is not allowed. The rabbit should not be pulled or lifted by the lead, neither between nor over jumps. The lead may not be used as whip. Do not cause stress to the animal by stomping or making loud noises or loud verbal commands/comments when going through the course. Doing any of these will result in penalty, up to and including disqualification.

- 2. Handlers may softly guide with an open hand and/or gently direct their rabbit with the leash while running the course. Touching the rabbit with your feet will result in a disqualification.
- 3. Rabbit is not to be lifted by the back skin, scruff or neck or the ears. Rabbit is not to be handled in any way that will cause harm to the animal.
- 4. Rabbit must be a minimum of 4 months old to begin training, larger breeds must be a minimum of 6 months old. Rabbits competing in Long Jump and High Jump must be a minimum of 9 months old.
- 5. Rabbits must be in "jumping condition" to be eligible to participate. Jumping condition is defined as: free from illness, sore muscles, sore hocks, long toenails, stress, pregnancy, nursing, breathing difficulties and/or any condition that may cause the rabbit or other rabbits in the area harm.
- 6. The judge, superintendent, Extension Agent or Fair Board Member has the authority to stop the participation of any rabbit that is in questionable physical condition.
- 7. All jumps must be the type that allows the jump bars to fall free from either side of the jump.
- 8. Rabbits must be on a leash and harness at all times while in the area of competition and outside the small animal barn. A 6 foot leash and proper fitting "H" style harness is required. No elastic leashes or breakaway harness/leash will be allowed.
  - 9. Rabbits must be supervised at all times.
- 10. Handlers may not go over the jumps with their rabbit
- 11. Poor sportsmanship will not be tolerated. Any handler exhibiting poor behavior such as swearing, yelling at their animal, excessive or harsh corrections, loud complaints about other exhibitors or judge, etc will be eliminated—receiving no award.
- 12. A rabbit that is unable to complete a course for any reason (including leaving the ring, ceasing to

- 3. 4-H members must compete in the written test at a date TBD by CSU Extension Agent to be eligible for awards in the supreme animal contest.

Scoring is as follows: Written Test is scored 1-10, Carcass is scored top 10, 1-10, Rate of Gain is scored Top 10, 1-10, Live placing of designated animal is scored 1-10, Record Book is scored 1-10, to the tenth Also, Grand Champion receives 5 additional points and Reserve Champion receives 3 additional points.

# **Section 18D - Showmanship Contest**

#### **Special Rules:**

- 1. There will be a showmanship contest in each of the following departments: Beef, Sheep, Goat, Swine, Yak and Horse. The competition will be held before each species show.
- 2. These contests will be divided into two age groups: Junior and Senior, and are open to any and only bona fide 4-H member showing livestock in the 4-H Show. For the purpose of this contest only, Juniors 8-13 years of age; Seniors 14-18 years of age as of December 31 of the 4-H year.
- 3. Any showmanship animal must have been shown in a 4-H show class.
- 4. Contestants must show their own animals in this contest and may be asked to trade animals with other contestants at the discretion of the judge.
- 5. Contestants will be judged on their skill as "showmen", on their dress and the appearance of their animals before the judges. The breed or individual conformation of the animals shown will not be considered.
- 6. If an animal is discovered to have a testicle retained in its body cavity, the animal may be used in Open Show only. See pg24, rule 38

- 1. Champion and Reserve Champion ribbons shall be awarded only to exhibits that meet all the exhibit requirements and standards. Third through 10th Ribbons will be awarded accordingly to standards and requirements.
- 2. Grand Champion and Reserve Grand Champion exhibitors will be declared in each project of the 4-H section from designated class champions. In the Junior, Intermediate and Senior divisions, a Grand Champion will be selected from all champions from each age category. The remaining class Champion and Reserve Champion exhibit in the class from which the Grand Champion was chosen will be eligible for Reserve Grand Champion consideration.

IMPORTANT: For Specific requirements on each unit and class number, you will need to consult the Colorado State Fair General Projects Requirements Syllabus. Requirement sheets and the State Fair Syllabus are also available on-line at <a href="https://www.colorado4h.org">www.colorado4h.org</a> or you may contact the CSU Extension Office. Please ask for help if you need it.

#### Display of 4-H Exhibits

- 1. Display boards are great ways to share that information, but when viewers walk by, they spend only 60-90 seconds looking at each display board. Make yours stand out by highlighting the main points of your project in a fun, interesting way.
- 2. SHAPE Design your exhibit so information fits on the display.
- 3.SPACE Your display should only discuss one main topic. This will help it loo neat and un-crowded.
- 4. TEXT Make sure that all the text on your display is easy to read. Use a large font for the title, and smaller fonts for the headings and the body text. Text must be readable from 3 5 feet away. Use large bold letters. Dark letters on a light background works best.
- 5. SIZE Display boards for the county fair must measure 4 ft wide x 3 ft tall. They should be made of lightweight cardboard, not poster board. Pre-cut boards are available at most craft and shopping centers, **Park County CSU Extension Office has some for sale -\$5.** NO PART of your display may extend beyond these boundaries.
- 6. ATTACHMENTS When attaching pictures or objects to your board make sure they are secure. Use

#### 18E. Herdsman Award

The Herdsman Award will be presented to a youth member of the Livestock, Equine, or Poultry and Rabbit projects. The intention of the award is to recognize the exhibitor who displays the most care and respect for the condition of their animal(s) during the fair, and demonstrates the spirit of 4-H through their sportsmanship and support of fellow exhibitors. The following items will be considered by the Herdsman Judges in making their decisions.

- Cleanliness of animals, stall or pens and self.
   Stalls and pens include the section of aisle adjoining them.
- **2.** Cooperation with superintendent and sportsmanship.
- **3.** Proper care of animals, including disposal of waste materials and manure.
- 4. Neatness and cleanliness of feeding and watering utensils and prompt removal of same when not in use.
- **5.** Care of equipment and neatness of exhibit area.
- **6.** Contest will begin when animals arrive on the Fairgrounds.
- **7.** The Herdsman Judges will confer with the Superintendents and Fair Board before making a final decision.

Round Robin Showmanship Section 18F- Large Animal Round Robin Showmanship Contest Special Rules and Regulations:

#### Alpaca, Beef, Horse, Sheep, Goat, and Swine

- 1. To qualify one must enter in one of the specific species showmanship classes.
- 2. The 1st and 2nd place winners in the Junior and Senior Division of each species are eligible to compete in the Round Robin. If the 1st or 2nd place winners do not wish to compete, then the 3rd and 4th place winners will be allowed to compete. If a competitor wins 1st or 2nd place in more than one species they must declare the species they will show.

- 3. If a youth has an automatic berth in the round Robin by virtue of no competition, they must take that berth and that animal in competition even if they win elsewhere. Youth may hold only one berth in Round Robin.
- 4. If a youth entered in competition places in more than one species, they must notify the superintendent of Round Robin which species they will use in Round Robin. The third place individual will then become eligible in the vacated spot.
- 5. In all showmanship classes, 4-H members should show their own animals. Exceptions must be approved by the Fair Board , Superintendent and the Extension Agent.
- 6. Animals should not be released by one showman until it is controlled by another or an official of the contest.
- 7. Showmanship attire will be as listed in each breed section.
- 8. Scoring in the first round in Round Robin when the 4-H member is showing his/her own animal will be in the following point system:

9. Scoring on all succeeding rounds when the member is showing another member's animal:

# Section 18G- Small Animal Round Robin Showmanship Contest Special Rules and Regulations:

# Dog, Cat, Poultry, and Rabbit,

To qualify one must enter in one of the specific species showmanship classes.

2. The 1st and 2nd place winners in the Junior and Senior Division of each species are eligible to compete in the Round Robin. If the 1st or 2nd place winners do not wish to compete, then the 3rd and 4th place winners will be allowed to compete. If a competitor wins 1st or 2nd place in more than one species they must declare the species they will show. If no one is eligible, age substitutions cannot be made.

- 4. Only one exhibit in each class will be accepted.
- 5. If a member enrolls in two units of the same project (leathercraft for example: member enrolls in Unit 2 and Unit 3—they must exhibit the higher level—Unit 3). When a member takes two units at the same time, they should master the skills of the lower unit and therefore exhibit in the higher unit.
- 6. 4-H e-Records may be completed by pencil, ink or computer. The choice will not affect judging.
- 7. Display boards must meet the specifications. The standardized display board size of 4ft. X 3ft. Is to be used for 4-H projects. Available in the CSU Extension office for \$5.
- 8. Projects are divided by Junior, Intermediate and Senior age groups. The age for Junior is 8-10, Intermediate is 11-13 and Senior is 14-18.
- 9.Exhibit entries will be done online. The Extension Agent is to enter each exhibit online with a description for State Fair.

10. Entry Labels: Each exhibit and sturdy binder

- or 4-H Record book (containing e-Record and other materials) is to have a label containing the following: county name, county number, exhibitor name and age, department, division, and class. The label needs to be on the upper right hand front outside of the binder/notebook (outside) and on the exhibit (usually the back of the exhibit or on the flap). Be sure to read specific instructions on tags for some exhibits, example: leathercraft, clothing, heritage arts, etc. All exhibits must be accompanied by a completed label. For security reasons, do not list the member address on projects.
- 11. All Champion, Reserve Champion and placing award exhibits must be displayed and remain on display for the duration of the fair.
- 12. The management will not be responsible for loss or damage to exhibits, although it will use all care to ensure their safety.

Note: Exhibits of unusual size or shape may not be on public display. Exhibitor cards and ribbons will be displayed in project areas. All other projects will be displayed unless there is a safety, health or space issue.

In addition, exhibitors must be at least eight years of age, must not have reached their 19th birthday as of December 31 of the current enrollment year and must satisfy other eligibility requirements (if specified) for a class, to compete in that class.
- 2. 4-H members may enter only once in the same class.
  - 3. Members must be enrolled in the project (which may be broken down into units, levels or

#### JUNIOR LIVESTOCK AUCTION

Park County Livestock Committee Members

#### Special Rules:

The Park County Fair Junior Livestock Auction Sale is a terminal sale. All animals sold are to be harvested.

# ALL CHAMPIONS AND RESERVE CHAMPIONS MUST BE SOLD AT THE AUCTION!

- 1. The following meat animals will be sold: Beef, Sheep, Swine, Goats, Rabbit and Poultry Pen, Turkey, and any fowl species when exhibited.
- 2. Sales are limited to three (3) animals or pens per exhibitor with a maximum of two (2) large animal species (beef, sheep, swine and goat.)

However, all Grand Champions, Reserve Grand Champions and "Catch A" animals must sell. Therefore, a 4-H member could theoretically sell 8 large animals if they were all Grand Champions and Reserve Grand Champions. If they had a Grand Champion and a Reserve Grand Champion and one other animal, they could only sell the Grand and Reserve Grand Champion.

3. Steers less than 1000 pounds, Heifers less than 950 pounds, Swine less than 225 pounds, Lambs less than 100 pounds and Goats less than 50 pounds **WILL NOT BE SOLD AT AUCTION!** (Exception for Catch an Animals.)

\*Market Swine over 295 pounds can be sold at auction, but auction sale weight will be calculated using 295 pounds.

- 4. All market stock will be weighed at the fairgrounds. The official weight for entry and sale of livestock will be made at the time of weigh-in. State of Colorado certified Scale will be used. No early weigh-in of any animal is allowed. Animals offered for sale will be declared after live placing in the show ring.
- a. All animals to sell at the Livestock Auction must be at the initial weigh in (when/ if weigh in is held) and the final weigh in. The Livestock Committee reserves the right to review any and all hardship cases for sale eligibility and the decision of the Livestock Committee will be final.
- 5. All poultry and rabbits will be sold live and exhibitor will make arrangements with CSU Extension Office for processing. Buyer will pick up processed animal. The Livestock Committee will not take possession, nor be responsible for the health, safety and life of the animal.
- 6. A bill of sale, brand inspection or Ownership Affidavit will be required prior to weigh in.
- 7. All livestock exhibitors (beef, dairy, sheep, goats, swine, poultry, and rabbits) will be expected to maintain the barns and pens in a fashion pleasing for general public viewing and to change bedding daily. Failure to do so will result in forfeit of \$50.00 from sale proceeds. No removal of any animal exhibit will be allowed without the permission of the Superintendent and the CSU Extension Agent.
- 8. Sale time will be posted (SEE SCHEDULE) in the indoor barn area.

#### **STALL RULES**

- 1. Stalls shall be reserved when your fair entry is turned in.
- 2. Exhibitors must provide bedding for all stalled horses.
- 3. Horses must be fed, provided clean water, and stalls must be cleaned by 8:00 am and 8:00 pm. Stalls will be checked twice a day for cleanliness and care. Any stalls that are not adequately cleaned or horses that are not fed and watered shall be subject to a fee or forfeit of any class awards and class points.
- 4. Anyone using a stall or pen areas without a reservation shall be asked to immediately remove their animal and clean any mess that has been made. A charge of \$30.00 shall be subjected to a horse in a stall without a reservation. No refund will be available.
- 5. The Exhibitor shall be responsible to post a sign with the name of the exhibitor, horse, emergency contact numbers and any other pertinent information.
- 6. Stalls may be accessed when arriving by checking in with the Horse Superintendent or representative. Stalls will only be accessible after the Fair veterinarian has cleared the horse to be unloaded from the trailer. All horses must be checked before unloading.

Stalls that are ready to be evacuated shall need to be signed out by the Horse Superintendent or representative or your awards/monies shall be held by the Fair Board.

#### MCQUAID HORSEMAN IMAGE AWARD

Judging Criteria: Anonymous judges shall circulate during the entire 4-H Horse Show. A committee shall make inspections during the fair to determine the awards, taking into consideration the following points and rating 4-H members in the following areas:

1. Horsemanship safety - Judges shall penalize exhibitors of poor safety, including but not limited to: bareback riding, riding with halter and lead shank, more than one rider and other dangerous displays.

- 2. Participation of temporarily or permanently handicapped exhibitors shall be decided by the show management, or the judge, based upon the safety of the individual and/or other exhibitors.
- 3. Judges may penalize for unsoundness. The severity of penalty is at the judge's discretion.
- 4. Acceptable bits, equipment, and dress codes are outlined in the Colorado 4-H Horse Show Rule Book.
- 5. Level testing must be completed by June 1 in qualifying for the Park County Fair.
- 6. Parents, relatives, and leaders should refrain from excessive "coaching" from outside the arena. A judge may disqualify a rider if he/she feels the "coaching" gave an unfair advantage. Positive encouragement is allowed.
- with a safety harness fastened in place is required in over fences classes, gymkhana events, all walk trot classes, activities and practice sessions. Gymkhana generally refers to horseback speed events (timed or un-timed) that do not use livestock. Events not

7. A CERTIFIED EQUESTRIAN HELMET

generally refers to horseback speed events (timed or un-timed) that do not use livestock. Events not included in the policy are events such as calf roping, team roping, goat tying, and team penning that may be timed but use livestock.

It is the responsibility of the parent/ guardian of the 4-H member to see that the headgear worn complies with such standards and is in good condition. The state 4-H office encourages the use of ASTM certified/SEI approved safety helmets in all equine events. Protective headgear may be used in all classes and shall not be discriminated against.

- 8. In order to complete a 4-H Horse Project, the exhibitor must complete their record book with at least a 70% score and show one horse or pony in the showmanship class or a "4-H tour" acknowledged by the CSU Extension Agent, give a talk or demonstration and perform at least one community service activity and meet your club requirements.
- 9. All foals become 1 year old on January 1 and the age will advance one year each January 1 thereafter.
  - 10. GRIEVANCES- See Rule #22 on Page 6.
  - 11. 4-H Code of Conduct Rule will be strictly

- 9. A sale order will be developed and posted as soon as it is determined by the livestock committee. Persons and animals participating are to be lined up in order of sell at the appropriate time.
- 10. Livestock sold at auction becomes the property of the buyer when the auctioneer says "Sold". The responsibility for care of market animals sold in the market sale remains with the exhibitor (seller) until the animal is delivered to the hauler/processor. Arrangements for their care in the interim are the responsibility of the exhibitor.
- 11. Officers of the Livestock Committee shall be responsible for sorting market animals sold in the sale
- 12. 4-H animals sold by private treaty WILL NOT be shipped by the Livestock Committee. The buyer and seller must make their own arrangement for shipping and processing.
- 13. Private treaty sales will not be processed by the livestock committee. And are not eligible for buyback sales or tax incentives.
- 14. A 5% sales commission will be deducted from the proceeds of each animal sold to cover expenses.
- 15. Buy Backs: When a buyer donates the animal back to the sale to be auctioned off a 2nd time. The 2nd round funds may only go to a non- profit entity. The original buyer must declare before the sale who the 2nd round sale goes to.
- 16. To be eligible to sell at the Park County Fair Livestock Auction, members must attend a minimum of **six** of their 4-H Club's community business meetings. Members may make up missed meetings at any Park County chartered 4-H Community Club business meeting. Newly registered members who are not beef project members, must attend a minimum of **four** meetings. Club leaders are required to submit their attendance records by the second week of the following month to the Secretary of the Livestock Committee. The attendance records must be signed by the recognized 4-H Club Community Leader.

#### **NOTE OF INTEREST TO BUYERS:**

- 1. All sheep, swine, goats, and cattle will be sold by the pound.
  - 2. Transportation for sheep, swine, goats, and/or

cattle purchased at through the Junior Livestock Auction will be provided by Livestock Committee and/ or professional hauler to the designated packing plant.

- 3. Immediately following the market stock sale, the purchaser will be required to report to the sale clerk and pay for the animal purchased. No livestock will be released until payment is made. Cutting orders will be available to be filled out at that time or may be emailed to the processing plant; email cutting orders will be available at the clerk's desk.
- 4. The pick-up of processed meat will be the sole responsibility of the buyer. All Junior Livestock Auction buyers will have their sheep, swine, goat, and/or cattle shipped with transportation provided by the packing plant chosen by the Livestock Sale Committee.

#### JUNIOR MARKET SALE SUPPORTERS

If you would like to support youth at the Junior Livestock Auction Sale, and do not want to buy an animal, "Add-ons" are a possibility.

#### "Add-On" Facts:

- 1. Done at the time of the auction after each animal sold, or done beforehand by individuals or companies with signed notes or checks.
- a. Company or individual may give to a specific 4-H member or
- b. Company or individual may make a donation to be equally dispersed.

# **QUALITY ASSURANCE PROGRAM**

The purpose of this program is to ensure, through education and certification, that every 4-H Producer of an animal exhibited whether for slaughter or as a pet, be fed and maintained in a proper manner. Market animals are fed and maintained in order to provide a safe and wholesome product to the consuming public. Topics included in the program are: feed selection, nutrition, drug and chemical withdrawal times, proper administration of vaccinations and use of proper injection sites, Ethics, proper animal care and housing, and the importance of consulting a veterinarian or professional when you have a question or need help. 4-H market animal and horse project members must go through this program and pass a test, for 2 years and then when they move up an age bracket.

\*These classes do not offer a level I option for entry— For Working Ranch Horse, an additional qualification day for each unique horse/rider combination is required to be eligible to participate.

5. High Point Eligibility: Written Test, Showmanship and Horsemanship/Equitation are required for a contestant to be eligible for Western and English division. All six classes are required for a contestant to be eligible for the Ranch Horse Division High Point awards.

The written test and a showmanship class is required for a contestant to be eligible for the Gymkhana High Point Awards. Record Book scores shall be added to and used to determine overall highpoint and overall reserve highpoint awards in each age group.

Division highpoints are based on one rider / one horse combination. Multiple horses can be used toward overall highpoints, however an exhibitor may only use one set of points from each division. Exhibitors are also eligible for the "Super Team" award. To qualify exhibitors must use the same horse for all classes in all divisions.

#### **GENERAL:**

1. The Fair Board may, at its discretion, subject any horse to drug testing procedures by the Fair Board veterinarian. Any horse doctored or in any way improperly or unfairly tampered with before going into the show ring shall be disqualified. Colorado 4-H Horse Show Rule Book, most current edition shall preside on rules according to 4-H Horse Drug and Medications and Breed specific rules. Refer to the rule book for specifics.

9. Sr. English/Western Showmanship 1st and 2nd place shall advance to the Sr. Round Robin competition. If they forfeit their right to compete in Round Robin the next person in their division and age group will be eligible.

Int. and Jr. 1st-4th place in the English/ Western Showmanship class shall compete in a grand drive for the top Jr. placings, the exhibitors who places 1st and 2nd shall advance to the Jr. Round Robin competition. If they forfeit their right to compete the next person in their division will be eligible.

10. The Park County Fair 4-H Horse Show Management reserves the right to amend or change rules, combine classes and change times of scheduled classes at any time prior to the judging and due notice will be given to exhibitors of any changes.

#### **AWARDS:**

- 1. Points per class are figured on a 10-1 scale. Example If an exhibitor places 1st place they will receive 10 points, if they place 9th place they will receive 2 points. These points will be tabulated towards any high point awards.
- 2. Awards Presentation: Class ribbons will be presented at the arena gate following the completion of the class. Ribbons not picked up at the gate may be claimed at the 4-H Horse Show Announcer booth. Division high point awards will be presented following completion of the show.
- 3. Ties: Scores of the showmanship class will be used to break all ties. In the event a tie still exists, placing in the written test will be used.
- 4. A contestant may enter any and all of the classes in a single division that he/she are qualified to enter. To be eligible for 4-H Division Champion awards, the 4-H member may compete in the following classes:

- 4. All Events are required to be held inside a closed arena. During all runs, arena gates will remain closed. Failure to enter and leave the arena, mounted at a walk or trot may result in a disqualification. Only participating contestants, arena crew, and officials should be in the arena.
- 5. Rule Clarification Gymkhana A rider in gymkhana is considered on course from when the arena gate closes to when the arena gate reopens. Gymkhana division rules apply from the time of entry to the time of exit (gate to gate) for every rider.
- 6. Exhibitors may not approach a judge under any circumstances during the show. Any and all questions or comments must be directed through the Park County Fair 4-H Horse Show Superintendents. Exhibitors are encouraged to discuss show results with the Judge following the competition.
- 7. Exhibitors and/or parents or guardians may be disqualified and excused from the grounds at the discretion of show management or superintendents for any unsportsmanlike conduct or abusive action to a horse. Any exhibitor not adhering to the above rule may be disqualified and forfeit all points and awards.

In any 4-H class, horses showing signs of undue stress or inhumane treatment will be penalized. Any horse exhibited in a class that has evidence of abuse, such as a cut or abrasion showing clear evidence of fresh blood in the mouth, nose, chin, shoulder, barrel, flank, or hip area will be considered ineligible to receive an award in that class.

If a body condition score of 3 or less is assigned to any horse by the judge, Fair Veterinarian, CSU Extension Agent, or horse superintendent, that horse is ineligible to compete in any 4-H show or activity.

8. Exhibitor's animal must be under control at all times and handled in a safe manner. Riders who do not have their mounts under suitable control shall be excused from the ring. Judges and ring officials should interpret this wording to stress safety and courtesy to all riders in the class, and consider a horse as being sufficiently out of control at any time the rider is unable to manage the animal in the required class routine after reasonable corrective action.

- 2. Classes with less than three entries may be combined in the show ring at the discretion of the superintendent, however they will be placed separately.
- 3. In ALL divisions, showmanship is considered a tie breaker toward high point awards. In the case that there is still a tie after the showmanship score, written test score will be considered. An exhibitor will not be eligible for division or overall highpoint awards if they do not participate in both the written test and showmanship for their division. For the Gymkhana Division an exhibitor shall participate in a showmanship class (English, Western or Ranch Horse) or they will forfeit all points and awards from the Gymkhana Division.

# **Written Test:**

- 1. The written test is a Park County Fair 4-H Horse Show as a final tie breaker. The test will be online, and sent out by June 1, with a deadline to take the test by July 1.
- 2. Exhibitors may contact the CSU Extension office for any questions regarding the test.

# **Show Rules:**

- 1. Entries shall be completed and turned in by the designated date from the Extension Office.
- 2. Specific state and national contest rules will be observed in addition to the rules above. Individual class rules will follow the most current Colorado 4-H Horse Show Rule Book. The 4-H member is responsible for knowing the specific rules of the show in which he or she has entered. The rules in this book pertain to the Park County 4-H Horse Program.
- -Zero Score Rule In Western Horsemanship, Ranch Riding, Hunt Seat Equitation, Riding Control and Showmanship failure to complete the pattern will not result in a disqualification but will be scored accordingly. Riders who fail to complete the pattern as written cannot be placed above those who do but may still be placed. In Reining, Western Riding, English Control and Western & Ranch Trail failure to complete the pattern as written will result in a zero score.
- 3. Dress Code: Contestants are required to follow 4-H dress code at all times as the Park County Fair 4-H Horse Show is a 4-H event. Contestants will

# **Department 20 - 4H Horse Show**

# **Exhibitor Eligibility:**

1. Exhibitors in this department must be members in good standing of a Park County 4-H Club. Exhibitors who are at least 8 years of age and have not reached their 19th birthday as of December 31st of the previous year are eligible (See Rule 2 in the 2020 4-H Horse Show Rule book). All entries made in this department are subject to the Park County Fair 4-H Horse Show Competition and Entry Requirements.

- 2. The Park County Fair 4-H Horse Show is a 4-H show and not an Open or FFA Horse Show.
- 3. All exhibitors must have completed Colorado 4-H Horse Project Advancement Level I in any division to be eligible to participate in the Western Division, English Division and Gymkhana Division. Entrants in the Hunter Hack classes must have passed Colorado 4-H Horse Project Advancement Level III English to ride over fences. All exhibitors must have completed Colorado 4-H Horse Project Advancement Level I Ranch Horse. For Working Ranch Horse, an additional qualification day for each unique horse/rider combination is required to be eligible to participate. Specific state and national contest rules must be observed in addition to the above rule.
- 4. All exhibitors who have not completed Colorado 4-H Horse Project Advancement Level I in any division will be eligible to show in the Walk Trot Division.

# Horse Eligibility:

- 1. Number of Horses: Exhibitors may bring a total of two (2) horses regardless of how many divisions they choose to enter. Exhibitors are restricted to one entry per class.
- 2. Ownership and Identification: Ownership is not required in order to participate in the Park County Fair, but Exhibitor must have a valid Lease if they do not own the horse or horses they are showing. However, the exhibitor must have provided majority management, care and training of the horse during the current 4-H year. The parent's signature on the entry blank should attest to this fact. All horses entered in any division must be included in the exhibitors Horse Project Record Book and declared (completed identification certification on file at county Extension office) as a project horse in **4Honline as of May 1st** of the current year. No substitution of horses will be permitted under any circumstances unless the substitute horse meets the above requirements.

- 3. Horses Shared by Siblings: Horses may be shown by siblings if they show or are entered in different age divisions or classifications. Please see the most current Colorado 4-H Horse Show Rule Book regarding rules on exhibitors using the same horse, rule 4C. The Park County Fair 4H Horse Show will follow the Colorado 4-H Rule Book regarding the rule addressing this matter.
- 4. Stallions over 1 year of age are not permitted to compete in the Park County Fair 4-H Horse Show.
- 5. In the case of death of an animal, the 4-H member will be required to file a hardship case with and the Park County Extension Office no later than 7 days prior to the show and the replacement horse must have been submitted on a Horse ID form prior to May 1st. Hardship letters must include:
  - A. A veterinary statement of death from a Fair Board approved veterinarian.
  - B. If a lease is applicable, leases must be completed in 4-H online.
  - C. A Letter from the 4-H member stating the circumstances leading up to the hardship.
  - D. The CSU Extension Agent shall accept or reject the hardship case based on the information presented. If replacement of a horse is required, the 4-H member must continue the record book with the new horse.
- 6. The member shall keep a 4-H Record Book on their project horse(s), attend the required 4-H club meetings, be active in community service projects, help with club fundraisers, participate in club practice rides and actively participate in the local club program to be eligible to participate in the Park County Fair 4H Horse Show..

# **Park County Fair Class Divisions:**

1. The show is divided into four separate point counting divisions: English, Western, Gymkhana and Working Ranch Horse. Exhibitors may compete in any or all divisions. Exhibitors may not sign up for additional classes after the Park County Fair 4-H Horse Show entry deadline. Individual classes in each division are divided by age. Ages are determined as of December 31 of the previous year. Junior 8 -10, Intermediate 11- 13, Senior 14- 18.
